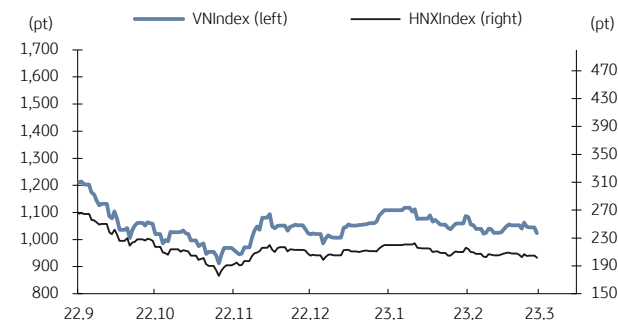

Vietnam stock market dropped sharply with increased liquidity, led by banking and securities stocks. Foreign investors were net sellers, focusing on Hoa Phat Group (HPG, -2.0%), Vingroup (VIC, -0.8%), and Dragon Capital (FUEVFVND, -0.9%).

According to statistics of the US Department of Agriculture, in January 2023, the US imported 267.6 thousand tons of fishery with a value of USD2.26 billion, down 3% in volume and 12% in value over the same period in 2022. Of that, 18 thousand tons of fishery products are from Vietnam, down 30% YoY. Fish exporters like Nam Viet Corp (ANV, -1.64%) and Vinh Hoan Corp (VCH, -3.45%) were upset.

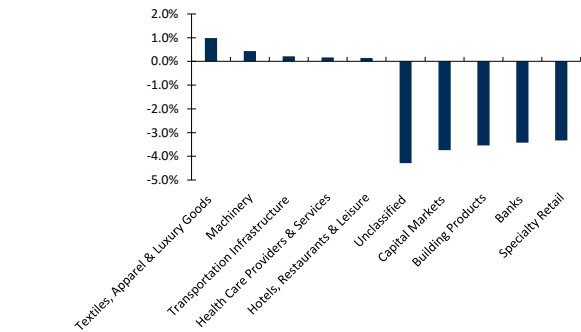
Steel prices today on the Shanghai Exchange fell CNY15 to CNY4,219 per ton. Plus, the recovery in China's crude steel production in the first two months of this year was not as strong as expected. This made steel shares like Hoa Phat Group (HPG, -1.96%) and Nam Kim Steel (NKG, -3.5%) decrease.

VN Index & HNX Index



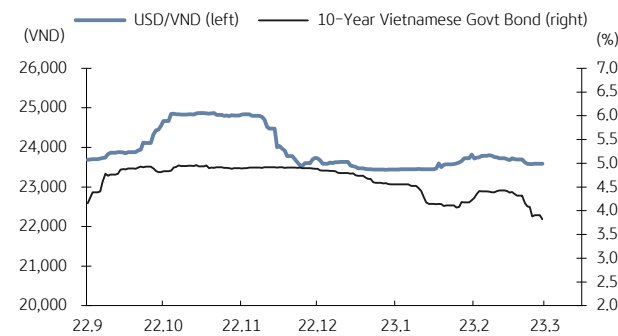

VN Index sector performance



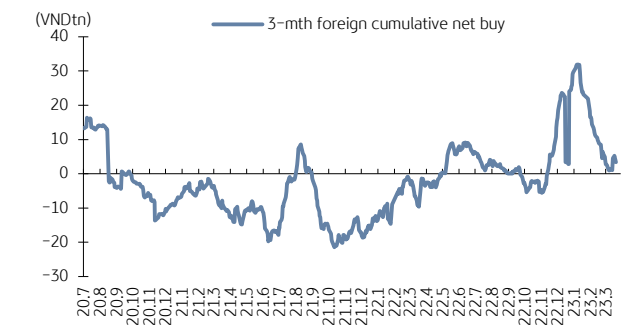

Vietnam - 3-mth cumulative net foreign buy



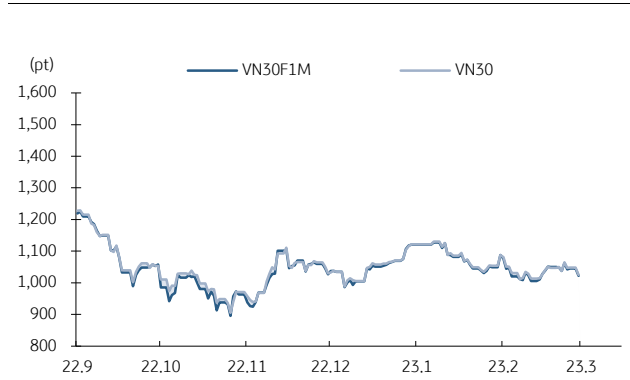

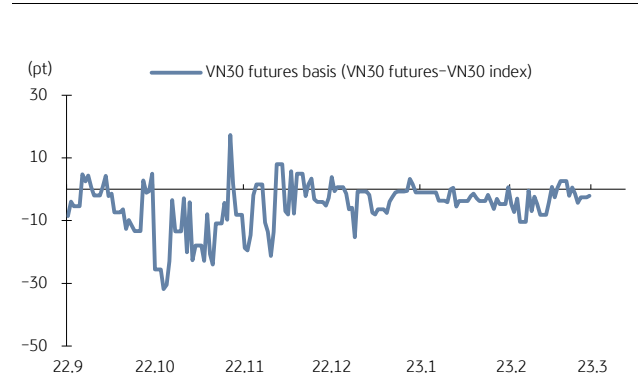

VN30 futures & VN30 index



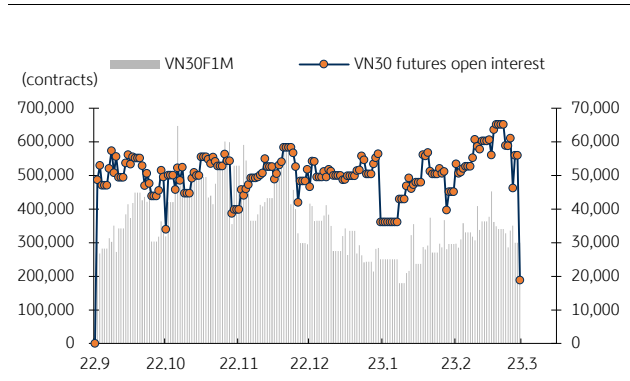

Front month VN30 futures basis



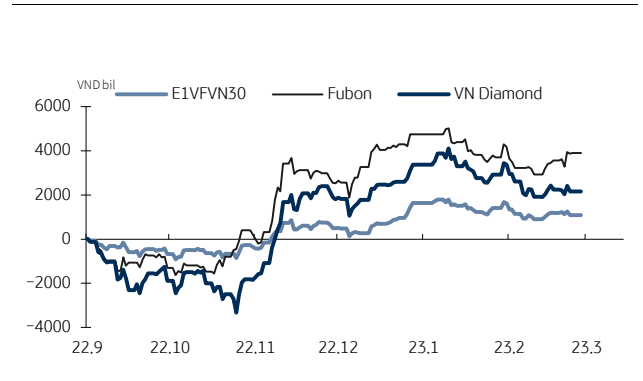

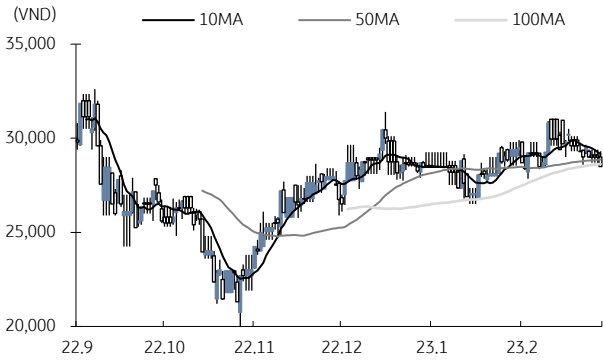
Vietnam ETFs - Changes in Fund Total Asset

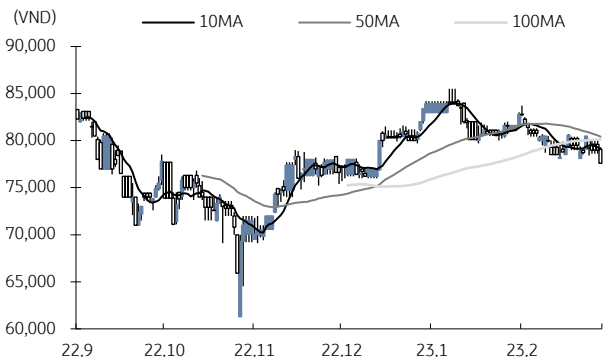

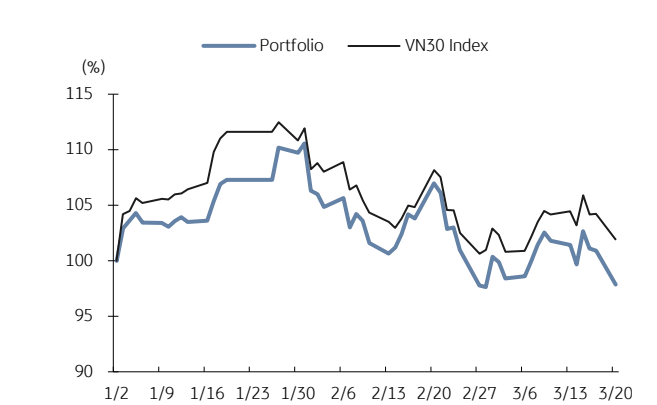
