Stocks advanced with increased liquidity, led by banks. Foreign investors were net sellers, focusing on Vietnam Prosperity Bank (VPB, +3.1%), Tien Phong Bank (TPB, +0.54%), and BIDV Insurance Corp (BIC, -6.86%). According to the General Department of Customs, the export turnover of fisheries in the first five months of 2023 reached about USD3.4 billion (-29% YoY), which led fisheries stocks Nam Viet Corp (ANV, -1.13%) and I.D.I International Development & Investment (IDI, -0.75%) down. The Department also estimated the fertilizer export volume in May at 154,995 tons (+17.5% YoY), which benefits fertilizer shares like PV Ca Mau Fertilizer (DCM, +0.38%) and PV Fertilizer & Chemicals (DPM, Unch).

Net foreign buy (U\$mn)





VN30 futures volume & open interest






Vietnam ETFs - Changes in Fund Total Asset

Market Movers




- ANV closed up 1.13% to VND35,100.

- ANV set a modest PBT target for 2023 at VND500 billion (-35% YoY) on revenue of VND5,200 billion (+6% YoY). The corporation plans to pay 2022 dividends in cash (VND1,000 per share), totaling VND133 billion for the current outstanding shares. ANV will ask for shareholders' approval of the plan to raise capital via the issuance of 133 million shares (equal to VND1,331 billion).

Techcombank (TCB)



- TCB closed up 0.92% to VND32,900.
- TCB bought back all VND3,500 billion in bonds (codes TCBL2225007, TCBL2225008 and TCBL2225009) before maturity from June 16 to June 21. These bonds were issued in June 2022 and would mature in June 2025.
