# 6. Steps to join Mini game KB-Crush

- Step 1: Customer logs in to "KB-Fina" application to open a securities trading account of KBSV.
- Step 2: After successfully opening a securities account, Customer performs/presses the option to join the Mini game program.
- Step 3: Customer answers two (02) questions about securities knowledge
- Step 4: Customer after correctly answering two (02) questions in Step 3 will press the spin prize's button:
  - If customer wins the box **"Stock ticker"**: Customer will receive a gift redeemed from the winning Stock ticker according to the program's regulations. At the same time, customer has run out of turns to participate in Mini game for the remaining time of the program.
  - If customer wins the box **"Good luck next time"**: Customer will have one more (01) turn in the next day (from 00:00 in the next day)



**Note:** Each customer has one (01) free turn/day (applicable to 23:59 on the same day) and it does not accumulate to the following days if not used up.

## 7. Principles of determining and ways of awarding prizes

- The value of the gift is determined as soon as Customer wins the "Stock ticker" box and Customer will receive a notification on the KB-Fina app within twenty-four (24) hours from the time of winning.
- One (01) ID number/Citizen identity card can only receive one (01) gift.
- Gifts will be given to customers who meet the participation regulations of the Organizer.
- Winning customers are obliged to pay taxes according to the regulations of the Government. In case Customer refuses to pay tax as prescribed, this Customer will not be received the gift. The Organizer will withhold personal income tax on the value of the prize that Customer wins and on behalf of the Customer completing the tax payment procedures with the management agency as prescribed.
- The list of winning customers is posted on KBSV's website and in articles related to the program. After one (01) day from the date KBSV announces the list of winners, if there is no dispute or complaint about the winner, the gift will be given to the customer as announced. If there is a dispute, the Organizer reserves the right to make a final and effective decision.
- After three (03) working days from the date KBSV announces the list of winners, the gift value will be transferred by KBSV to the customer's securities account (SA sub-account) at KBSV.

#### 8. General regulations

- Customers, participating in the contest, automatically agree with the contents given in this program content and /or other regulations arising during the participation as notified by the Organizer.
