- Customer identification may be inaccurate, and security errors may occur;
- Market prices and other securities information may be erroneous or inaccurate;
- Telecommunication networks used to place orders via phone, retrieve transaction information, or receive notifications may experience failures, overloads, or network congestion, preventing the customer from executing transactions or receiving requested information;
- The System (including hardware and software) of KBSV and related third-party systems or services provided via the System may experience interruptions, freezes, delays, errors, malfunctions, or virus infections;
- Transactions may be delayed, corrupted, disrupted, missed, or malfunction due to maintenance activities on the System;
- Electronic protection measures, including filtering or anti-virus programs, may fail or encounter issues.
